Please do not use road to field or fly if road or field is too wet from recent rain.

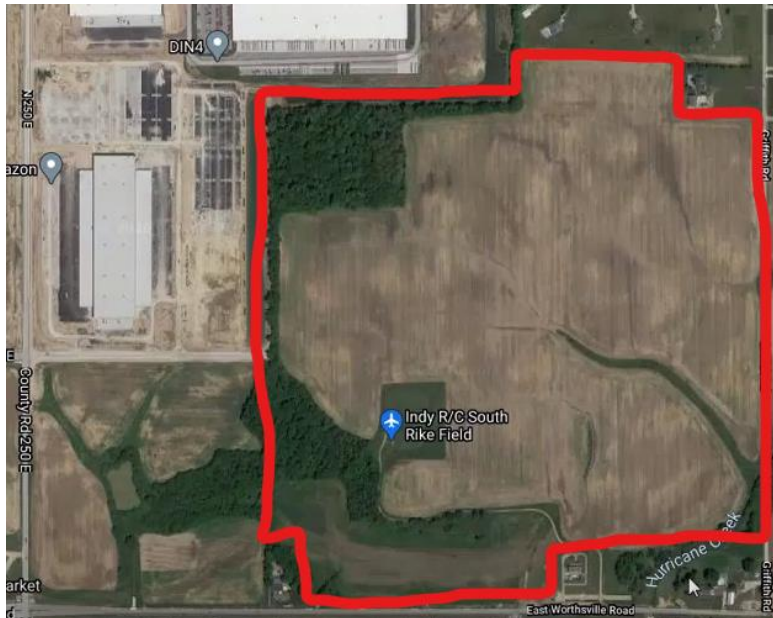
Please remember to lock both gates if you are the last one to leave and scramble the combination.
