Potential Site # 25

Duane & Jerry located this site. One landowner but would need an access road installed. Owned by brothers in Kansas.

East of N 875 W & North of W 700 N. Letter sent to landowner. No repose yet.

Potential Site # 27

South side of E 500 N & West of 575 E. Multiple landowners. Letter sent to primary landowner. No repose yet.

Potential Site # 28

North side of E 500 N & West of 525 E. Multiple landowners. Letter sent to primary landowner. No repose yet.

Potential Site # 29

West side of US31. North of Franklin behind a church (owner saw article in paper). Many obstructions (soccer goals & trees). Considered not viable.



Potential Site # 30

East side of Morgantown Road & South of Olive Branch Road (owner saw article in paper). Another church. This is part of a FootGolf Course. Many obstructions. Considered not viable.

Potential Site # 31

East side of 525 E & South of 400 N. Heard back from primary landowner. Does not want us on site we had identified but suggested an alternative site (owned by brother). Probably too tight (100' wide).
