Old Business

Rike Field Viability & New Field Search

As a reminder, Rike Field was Officially Closed on October 28, 2021. Still no signs of construction other than the erosion barrier.

- #39 (2.0 S) S of 600N/250E, northeast-facing small aircraft field parallel to interstate (Rob Kent)
 - Spoke with landowner, potentially interested, sent info - Park Flyer field ONLY
 - Overfly landowner passed 1/4/21 – trying to reach survivors.
- #50 (11.4 S) E of 200 E, S of E 300 S, east of Franklin Flying Field (Jerry McRoberts)
 - Jerry called again – Johnson Co now involved – call back in another month
- #51 (5.7 SE) E of 625E, S of 350N, hayfield behind house at 3093 N 625E (Rick Sallee)
 - Initially interested, zoning/tax questions – will try it out next spring after 1st cut
- #54 (11.5 NW) SE of Mann Rd/Southport Rd, NW corner of Southwestway Park
 - Park Upper Mgmt responded – not interested, unsafe, need to monitor
 - Received data from AMA - need to follow up with Park Mgmt
- #55 (7.6 SE) Dead end road (CR 150 N), ½ mile W of 2nd Mt Pleasant Baptist Church (Rick Sallee)
 - Finally heard back from County Hwy Dept – they are not maintaining road
 - Need to contact landowner north of road to see if interested.
- #57 (6.25 SW) Land S of 400N, between 200W and 150W (Chip Hurkmans)
 - One of Chip's neighbors – wouldn't answer his calls.
 - Mailed info, no response. Chip working another angle to contact him.
- #58 (14.0 WSW) Land SE of Centenary Rd, at approx 6398 (James Craig)
 - Land owned by Bex Farms Inc located in Kalamazoo, MI.
 - Have contact info for their agent and will try to contact him.

New Business

Chuck mentioned that he had attended the Johnson County Swap meet held at a new location at the Johnson County Fair Grounds and that it was very nice. It is planned to be held there again next year. Donated items to benefit our club were sold at the swap meet totaling \$225.

The club Holiday Dinner will be March 5, 2022, at Dye's Walk. Cost is \$25 per person. The doors will open at 5:45 pm and dinner will be served at 6:45 pm. There may be a swap meet at Center Grove on 4/9, but not confirmed yet.



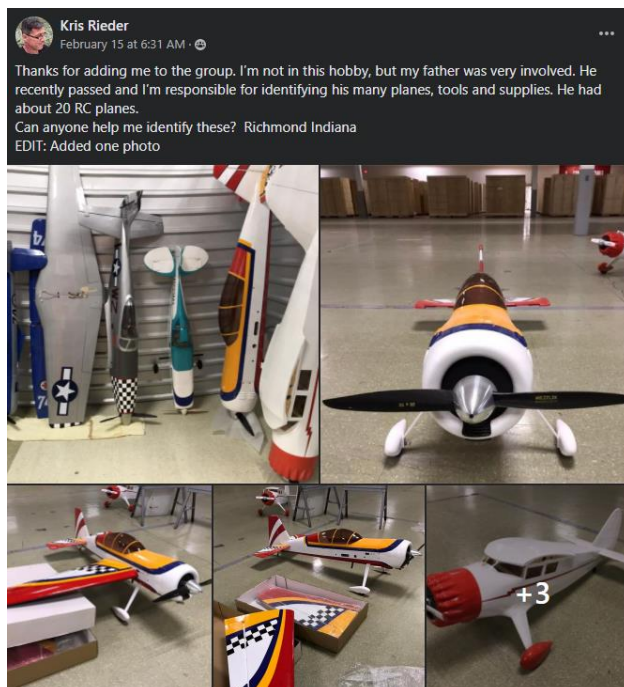
